## C. Local Areas 1 & 2 have been combined into one region

• LA-1: Aroostook & Washington counties and LA-2: Piscataquis, Penobscot & Hancock counties have combined to form one Local Area/region, known as the Northeastern Region. In addition, Mike has been advocating that each Local Area in Maine become a region. This is now part of draft state plan.

## E. Regional Planning Committee

- At last meeting, Lydia appointed a group of board members to be on the Regional Planning Committee: Kelly Flagg, Linda Winton, Denise Griffin, Peter Russell & Neil Williamson
- State has come up with goals for the State Plan our goals need to align with the state's goals.
- Received assignments to put together draft goals & strategies discussed & tweaked. Results laid out on sheet in packet.
- Due to timeframe of state plan, local plan target date has been moved to June 2016.

#### F. H-1B TechHire Partnership Grant.

- A couple of weeks ago, USDOL came out with H-1B grant solicitation.
- Educate Maine reached out to CCWI to partner for the 4 year, \$5mil grant.
- Statewide grant will include other regions.
- CCWI has hired Sally DelGreco and she is already working on application
- This grant will allow us to work with paid internships and develop career pathways for IT with companies for future jobs

#### III. GOODWILL UPDATE

Heather Stott, Goodwill Senior Director

#### A. Service Delivery Update

- Activity report for previous quarter (ending Sept 30, 2015) shows service for adults at 144% of goal. Service to dislocated workers is at 74% of goal.
   National Emergency Grants (NEG) have also been implemented to serve them, so WIA numbers are less, but that allows GINNE to focus more on adults.
- Working with CCWI on Sector Partnerships

- Collaborating with Adult Ed in our area: Bonney Eagle Adult Ed, MSAD 55, Lincoln County Adult Ed
- Expansion provides easier access in more rural areas & Adult Ed is one of 4 major core partners under WIOA.

#### IV. YOUTH STANDING COMMITTEE UPDATE

Jamie Grover, Goodwill Senior Program Manager

- At their meeting last week they discussed Regional Plan with Sally DelGreco
- Highlighted changes in transition from WIA to WIOA age increase to 24, and the needs of the financial services sector
- 75% funds need to be spent on out-of-school youth, and 20% of funds spent on work experiences—consistent with how we currently operate.
- Appointed new member to YSC Rebecca Thompson, Dir. of Classifications at Longcreek. Helps youth at Longcreek do off-grounds work.
- In November, they held a workshop at the Rockland CareerCenter that focused on social media personal, professional & security measures. Workshop was very successful.

#### V. MAKE IT IN AMERICA / PREP GRANT UPDATES

Don Marino, CCWI Program Manager

#### A. Make It In America (MIIA)

Because our performance with this grant has been so good, CCWI was asked to present 3 webinars to other MIIA grantees across the country. This covered:

- How we do our participant follow-up
- Utilization of MIIA internships and the roles that plays in upskilling and backfilling
- Synergy among grant agencies
- Maintaining contact with participants after exit from our programs
  We are beginning year 3 of grant. Will continue with existing work and make some improvements, possibly requesting a modification to our USDOL contract.

#### B. Pre-Release Employment Project (PREP)

- Started July 1, 2015 with a 4-month implementation period, until June 2017.
- This is a 2-year, \$500k grant USDOL discretionary grant
- Partners involved: CCWI, Goodwill, Cumberland County Jail, Cumberland County Department of Corrections, Cumberland County Government & City of Portland.
- Goodwill will establish an American Jobs Center at the jail in order to provide workforce development & re-entry services for inmates due to be released in 180 days

# VI. TECHNOLOGY OCCUPATIONS THROUGH PATHWAY STRATEGIES (TOPS) Sarah O'Connell, Program Manager

## A. Technology Occupations Through Pathway Strategies (TOPS)

- This is a \$5mil grant, began October 2011, extended to 11/30/16 at no cost
- Partners include Southern Maine Community College (SMCC), Goodwill, New Ventures Maine (formerly Women, Work & Community) and Midcoast Regional Redevelopment Authority (MRRA)
- Provides OJT & classroom training employers are reimbursed 50% wages
- New Mainers population has not been utilized, many are skilled but have language barrier
- Will provide intensive English language classes that will lead to OJT contracts
- To date, we've already hit our enrollment goal of 374, with still a year to work with it
- Goodwill is really doing a good job at recruiting and increasing participants
- Extending our contract with New Ventures Maine to 4/30/16

## B. Sector Partnership National Emergency Grant (SP-NEG) & Job Driven National Emergency Grant (JD-NEG)

- SP-NEG focuses on IT, Healthcare and Advanced Manufacturing enrollment is not open yet
- Although not directly industry specific, we are working under JD-NEG on the Transportation/Logistics and Banking
- C. Joy Gould introduced herself, gave her background info. Been at CCWI for 2-weeks. Will be working on JD-NEG.

- Employment growth is slow and still below pre-recession levels
- People ages 55+ are continuing to work later in life
- Biggest challenge is the deficit of workers and getting youth excited about new careers

Because WIOA requires CCWI to maintain more specific labor market information beyond what the state produces, CCWI did a solicitation for specialized region numbers. The Maine Center for Business and Economic Research responded and produced a report for us.
