#### IV. SUMMARY OF WORKFORCE BOARD ACTIVITIES – CCWB Chair Lydia Sy

CCWB Chair Lydia Sy reported on the following:

- A. WIA (Workforce Investment Act) Reauthorization WIOA (Workforce Innovation and Opportunity Act) was signed by President Barack Obama on July 22, 2014.
- B. New OMB (Office of Management and Budget) Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards Final Rule CCWI staff are taking proactive measures to ensure compliance with the new federal law.
- C. MIIA (Make It in America) and TOPS (Technology Occupations through Pathway Strategies) grants continue to provide significant opportunities.
- D. CCWI has contracted with CAEL (Council for Adult and Experiential Learning) to analyze and isolate industry sectors that would be well suited for career pathway models in our region.
- E. CCWI staff will begin working on the Local Plan in August.
- F. Board members are encouraged to share their expertise and participate in projects or tasks when asked.

#### V. THE YEAR AHEAD – CCWI Executive Director Mike Bourret

CCWI Executive Director Mike Bourret reported on the following:

- A. Upcoming challenges and opportunities
- B. WIOA Implementation timeline of activities
  - a. December 2014 began process of board composition compliance
  - b. March 2015 contracted with CAEL for development of career pathway models within industry sectors that we will be focusing on in next couple of years
  - c. Partnership meetings coming up in June Adult Ed Directors, CAEL, and MDOL (WIOA Steering Committee, Performance Standards Subcommittee, One-Stop Committee, Unified Plan Subcommittee)
  - d. Governance Agreement has been updated.
- C. OMB Guidance consolidating financial rules and regulations to make things easier. We will need to review existing contracts/agreements to ensure compliance. We have put out an

- RFP for help with reviewing existing financial manuals and policies and amending them to ensure compliance. Hoping to have this work completed by September 2015.
- D. WIOA comment period. CCWI has comments to submit. These have been shared with board members, MDOL and USDOL. Board members are encouraged to submit comments as well. There may be one or two areas that the delegation may want to weigh in on. Discussions were held with delegation staffers in DC a specific point of concern is for the ability of the new Act to allow the system to do incumbent worker training without the layoff requirement.
- E. From time to time, board members will be asked for their feedback and to participate in ad hoc committees.
