HIGHLIGHTS OF CCWI'S 2013 EVENT

Charlie Crosby, President of the Board for CCWI, and a Sagadahoc County Commissioner, welcomed board members and guests. Commissioner Crosby remarked, "This is a very special event for us all. It is always special when the County Commissioners, the Workforce Board, State partners, our Regional Employers, Education Providers, CareerCenter and Goodwill Workforce Solutions staff, customers and our many other partners come together for an evening of celebration and recognition." Special guests included: Bonnie Pothier of Senator King's Office, Jim Pineau of Congresswoman Pingree's office, Ted Stern, of Senator Collins office, President Ron Cantor, Jim Whitten and Joan Cohen from Southern Maine Community College, Commissioner Tom Coward and Cumberland County Manager, Peter Crichton from Cumberland County, Neal Allen from Greater Portland Council of Governments, Jeff Kobrock of Midcoast Council of Governments, Peter DelGreco from Maine & Company and Mark Ouellette from Mobilize Maine.

Robert Schmidt of LL Bean, Coastal Counties Workforce Board's Chair, spoke to events in Washington D.C. that have a direct effect on the workforce development programs and provided a summary of major CCWI regional workforce development accomplishments for the past year including:

- ✓ CCWI's meeting and/or exceeding all Workforce Investment Act (WIA) National Performance Standards.
- ✓ CCWI orchestrating National Emergency Grants for multiple dislocations, providing training resulting in employment to over 1,000 dislocated and long-term unemployed.
- ✓ CCWI's completion of a successful Maine Health Education Collaborative grant involving four community colleges, hospitals which provided training to over 1,000 participants.
- ✓ CCWI completing the statewide Aging Worker Initiative—a successful national demonstration grant for over 200 mature workers.
- ✓ CCWI receiving a \$5 million discretionary (H1-B) grant entitled Targeted Occupations Pathways Strategies (TOPS) which is employer driven, STEM related, OJT based, and an industry partnership led effort.
- ✓ CCWI enrolling over 500 WorkReady participants since 2008—and the program is increasingly being integrated into Maine Career and Technical Education Centers (CTE schools) via Cooperative Education.
- ✓ CCWI's service provider's business reps placing over 200 unemployed workers in On-the-Job Training directly resulting in private sector employment.

Lydia Sy of Manpower and, Vice Chair of the Workforce Board, acknowledged CCWI's Chamber of Commerce partners as well as Economic Development partners for a wide array of initiatives that are occurring in all seven of the State's Economic Development Districts (EDDs).
