# IV. <u>Executive Director's Report</u> – CCWI Executive Director, Antoinette Mancusi

- A. Staffing Changes
  - 1. Jeremy Kendall, Program Manager has left CCWI
- B. One-Stop Center Infrastructure Agreement
  - 1. Letter was sent to MDOL stating that CCWI was going to invoke the State Funding Formula because efforts to negotiate an IFA have not been fruitful. No response was received from the State.
  - 2. Bureau Director Kim Moore said due to Covid, there wasn't staff available to move forward with the request. She would like to work on a resolution
  - 3. A decision on our further action needs to happen by the end of July due to policy changes.
- C. One-Stop Operator Contract
  - 1. CCWI has sole sourced the Cutler Institute as the region's One-Stop Operator.
- D. Opioid NEG Update CCWI Director of Operations, Jillian Sample
  - 1. CCWI has won a \$2.7mil award from USDOL to help individuals who have been dislocated due to Opioid use.
  - 2. 6 teams of Career Advisors & Life Navigators
  - 3. We opened the process for receiving referrals in July and have received 15 referrals so far.
  - 4. This award will serve 360 individuals over two years
  - 5. The plan was to have staff at Cumberland county jail, but all work is being done virtually due to Covid.
- E. COVID NEG Update CCWI Director of Operations, Jillian Sample
  - 1. Award was received 7/15/2020. Will be focused primarily on Cumberland County as that area was most impacted by Covid.
  - 2. Focus is on also providing imminent humanitarian aid (public benefits & resources)
  - 3. WFS will be hiring 10 disaster relief employment workers as navigators
